Attendees who do not comply with the camp's rules and standards, or whose conduct or attitude undermines the positive environment and objectives of the camp, or who have made any false, misleading or incomplete statement in this application or the Health History and Examination Form, are subject to being dismissed. If a worker is dismissed, he or she will be sent home at their own or his/her parent's expense.
